5.1 Aboriginal Community Liaison Officer Recruitment Update (11542942)

5.2 Bass Point Reserve Conservation Management Plan Update (11542943)

The purpose of this report is to provide an update on the Bass Point Reserve Conservation Management Plan project.

An update on the project was provided to the AAC at the August meeting and it was recommended that further community consultation take place with the aim to have more participation and contribution from Traditional Owners.

Following that meeting, various efforts were made to contact community members whose details were provided to the project team. Some feedback on the CMP was provided, and others who were contacted did not provide any input.

Furthermore, an additional geomorphology study was conducted at the Reserve on 18 September 2020 to further review the geomorphology of the area, with a specific focus on Aboriginal heritage sites – invitations for that activity were sent out on 11 September 2020. That study was attended by:

- Dr Peter Mitchell and Elaine Lin on behalf of Virtus Heritage
- Kayla Williamson and Paul Cummins of Woronora Plateau Gundangara Elders Council

Two midden sites were identified as being mapped in a slightly wrong location in the AHIMS database and will be corrected.

Dr Mitchell has revised his original geomorphology report with the following:

- The Bass Point Reserve is very important regarding Aboriginal culture and heritage
- Weeds and fire management are presenting an issue that require careful management
- Recommendations to complete more accurate midden mapping for certain middens
- Recommendations for the establishment of a joint management agreement that will enable Aboriginal parties to get closer cooperation with Council, a better opportunity for grant funding, and present real opportunity for Aboriginal heritage tourism ventures and Council driven education programs.

The entire Bass Point CMP document draft, including the Aboriginal Culture and Heritage chapter, will be provided to Council late October and will be circulated for comment shortly afterwards.

5.5 Stop Work at Reddall Reserve Play Facility, Lake Illawarra (11542946)

The purpose of this report is to provide information regarding the current stop work conditions implemented at the Reddall Reserve play facility construction site at Lake Illawarra.

On 16 September 2020, whilst undertaking excavations on the Reddall Reserve play facility construction site, some shells and shell fragments were identified. The shells and shell fragments were identified by the independent Site Observer engaged by Council to supervise the excavation works. Council elected to engage an independent Site Observer in a cautious approach to the site excavations which is over and above the requirements set out in the NSW Government Office of Environment and Heritage's (OEH) Due Diligence Code of Practice for the Protection of Aboriginal Objects in New South Wales (Code of Practice).

The shells and fragments are considered to be an unexpected find in accordance with the Code of Practice and therefore construction work on the site has ceased whilst consultation takes place with the OEH.

Council staff have been in contact with the OEH and a site meeting was conducted on 22 September 2020 with Rose O'Sullivan and Emily McCarthy from OEH. It is highly likely that an Aboriginal Heritage Impact Permit (AHIP) will be required before works can recommence. Council staff will continue to work with the OEH to ensure that the site is protected whilst investigative works take place and to ensure that all legislative requirements continue to be complied with. OEH will provide further advice on the way forward.
