6.1 Aboriginal Employment

A verbal report was provided by Manager Community Life, Bonnie Hittmann regarding the filling of the current vacancy for Aboriginal Community Liaison Officer. Interviews have been held and it is anticipated that the position will be filled before the end of the year.

6.2 Bass Point Interpretive Centre

A verbal report was provided by Bonnie Hittmann, Manager Community Life. Council has engaged consultant Jeremy Wilshire from Barking Dog Consultants, to conduct the market research to inform the new business case. This will be a desk based analysis of existing Aboriginal of First Nations (national and international) cultural centres to learn what could be included and successful in the Shellharbour Aboriginal Interpretive Centre.

The Committee members were asked to advise Bonnie of any cultural centres they think should be reviewed as part of the market research.

The findings from the market research will be presented to the Committee early in the new year and then Council will seek to engage a First Nations community engagement consultant to co-facilitate community consultation for the business case.
