Discover Shellharbour will replace the Museum's existing in-house database, provide an online searchable platform for all Museum collection items, and provide opportunities for community contribution and engagement.

The database will include First Nations cultural heritage objects and content that has been approved for public viewing by the AAC. The Museum welcomes AAC and relevant stakeholder contributions to the database, and will seek approval from the AAC for additional cultural heritage objects and First Nations content to be made publicly available on the database in the future.
