# 8.1. Installation of Trailer Only Car Parking - Towns Street, Shellharbour

Committee Recommendation

That Council:

1. Approve the modification to the existing parking zone on Towns Street, Shellharbour as shown in **Attachment 3.** 

- 2. Approve the installation of parking restrictions in the carpark near Towns Street. Shellharbour as shown in Attachment 3.
- 3. That Council Officers review the existing 'No Parking' zones near the boat ramp to ensure zones are appropriately 'closed'. Should there be no sign 'closing' the zone, install a 'No Parking' sign at the exit of the nearby car park.

- 2. NOTE further clarification from Transport for NSW was sought on the exemption for waste collection vehicles crossing Double Barrier (BB) lines on Tyrrel Street, Flinders. Advice will be provide to a future meeting of the Traffic Committee.

## 8.3. Installation of 'No Stopping; Signs - Harbour Boulevard, Shell Cove

That Council unanimously decline the recommendations set out in item 8.3 of the Business Paper on the grounds that:

- NSW Road Rules (198) currently prohibit vehicles from obstructing access to a footpath, and so, installation of signage is superfluous and an unnecessary precedent.
- Transport for NSW representative considered that the slight increase to the 'No Stopping' zone proposed would have little benefit from a road safety perspective.
- Note: Traffic Committee representatives highlighted that pedestrian crossing points in Shell Cove will become a more prominent request as development continues.

Council Officers highlighted that further review on crossing points would be captured within Councils future Pedestrian Access Mobility Plan (PAMP).

**UNANIMOUS DECLINE** 

#### **Proposed Committee Recommendation:**

Council Officers undertake further investigation including reviewing the Shell Cove Pedestrian Plan, taking it back for community consultation and report back to the committee.


The NSW Police Representative requested the complainant to contact the police directly if the illegal parking in Panbula Place, Flinders is occurring over night.

#### Attachment 2 - Email received from Albion Park Chamber of Commerce

The Chamber has received questions regarding the following intersections on Tongarra Rd Albion Park.

#### 1. Tongarra Rd – Church St.

Another accident at this intersection recently has raised questions again regarding the safety of this intersection, for traffic and pedestrians.

At the July 4<sup>th</sup> 2018 Traffic Committee meeting the committee recommendation was.

2. Seek advice from RMS regarding the timing for installation of traffic lights at the intersection of Tongarra Road and Church Street, Albion Park and ask if RMS is in a position to accelerate the installation of traffic lights considering the current and developing circumstances.

Could Council please provide an update on what is happening with these lights?

#### 2. Tongarra Rd - Terry St.

Could Council please investigate options, such as signage or lane markings, to improve the safety at this intersection. The reported problems are with west-bound traffic.

Specifically, traffic in the LH lane normally turns left into Terry St but also drive west through the lights to access the Hotel carpark and the shopping centre. This practise does help to ease traffic congestion at the lights.

While traffic in the RH lane would normally drive west straight through the lights, some also believe they can turn left into Terry St.

This practise has a knock-on effect as traffic turning into Terry St from the LH lane will generally move straight into the RH lane as they are turning, not expecting anyone in the RH lane. Vehicles will attempt to be in the RH lane ASAP, due to the lights and parked vehicles further south on Terry St.

We are aware that this may be a driver education problem, or infringement, but a simpler solution needs to be found.
