- Payment of the Annual Registration Fee of \$501.00 for the period 1 July 2023 30 June 2024
- Copy of current Public Liability Insurance with the Sum Insured being \$20,000,000 listing Shellharbour City Council as an interested party or principal
- Copy of current Workers Compensation Insurance, if you have any employees
- Copy of current Department of Fair Trading Licence Card for all certifiers (front and back)

The information that Council is collecting from you is deemed to be personal information under the *Privacy & Personal Information Protection Act 1998 ('the Act')* but may be disclosable under the *Government Information (Public Access) Act 2009.* The list of approved contractors will be made available on request to applicants for driveway construction and they may contact you for a quote.

The fee and any necessary documents are required to be completed and submitted to Council if you want to be included on the listing.

### REQUIREMENTS TO BECOME A COUNCIL APPROVED DRIVEWAY CROSSING CONCRETE CONTRACTOR

- 1. The attached application form must be completed and lodged with Council.
- 2. Contractors will be required to register each financial year and pay the annual registration fee of \$501.00 for the period 1 July 2023 to 30 June 2024.
- 3. The name of at least one Certifier who is responsible for certifying that the work done complies with Council's standards together with an original and current Department of Fair Trading Contractor licence card (general concreting, structural landscaping) must be provided at the time you lodge your application. Our Customer Service counter staff will make a copy of your contractor licence card and return the original to you.
- 4. You must sign the attached application stating that you:
  - a. are able to read plans, understand levels and able to carry out construction in compliance with plans and levels
  - b. you fully understand Council's vehicular crossing drawings and standards and agree to perform all work in strict accordance with Drawing Numbers ASD 100-106 and ASD 200-214 or updated versions from the Shellharbour Engineering Code and the specifications contained within these drawings
  - c. you will check formwork and ensure the formwork is correct and ensure that the Council formwork inspection has passed prior to placing concrete
  - d. you understand that your work will be subject to a formwork and final inspection and testing and you may be struck off the list of approved contractors if your work is found to be falsely certified and/or does not meet Council standards.
- 5. You must provide Council with a copy of your own Public Liability insurance cover which must be for an amount of \$20M.
- 6. You must provide Council with a copy of your own Workers Compensation insurance cover where applicable.

An application will not be processed until all the above requirements have been met.
